

All groups compete in the quiver disciplines.

All groups with 10th - 7th kup compete in soft kick (foam fighting).

All groups with 6th-5th kup compete in point fighting.

All groups from the 4th kupu compete in the discipline of sparring.

B) Discipline SOFT KICK (foam pole fight)

Only holders of 10th - 7th kupu compete

Protectors and equipment

- competitors may wear a head protector
- competitors fight with a foam pole of approx. 60 cm length

Scoring

- head shot 2 points
- leg or body hit 1 point
- hand hit 0 points
- admonishment leaving the ring, dropping the foam noodle, touching the ground with a part of the body other than the foot
- for 2 admonitions the opponent receives 1 point

Height categories

- ninja boys/girls -120, -130, +131 cm
- younger youth boys/girls -140, -150, +151 cm
- older boys/girls -150, -160, +161 cm
- younger boys/girls -160, -170, +171 cm
- older male/female juniors -170, -180, +181 cm

C) Discipline POINT FIGHTING

Only holders of the 6th - 5th cup compete.

Protectors and equipment

- Arm, leg and head protectors MUST NOT be red or blue
- 10 oz closed gloves are required for all age groups, except students
- Pupil age groups are allowed open, closed and max 10 oz gloves as long as they fit the size of the hands and the build of the competitor
- The approved protectors for competitors are governed by the list of approved protectors for competitions organized by the Czech Taekwon-Do ITF

Scoring

- punch 1 point
- leg kick to the middle zone 2 points
- leg kick to upper zone 3 points

Height categories

- ninja male/female -120, -130, +131 cm
- younger youth male/female -140, -150, +151 cm
- older youth male/female -150, -160, +161 cm
- younger juniors male/female-160, -170, +171 cm
- older juniors male/female -170, -180, +181 cm

D) Disciplína MATSOGI (sportovní boj)

The competition is open exclusively to holders of the 4th kupu and higher. "Mandatory turn" will not be applied.

Protectors and equipment

- juniors have the recommended chest protector
- Hand, leg and head protectors MUST NOT be red or blue depending on the side of the ring
- 10 oz. closed gloves are required for all age groups, except juniors
- Pupil age groups are allowed open, closed and max 10 oz gloves as long as they fit the size of the hands and the build of the competitor
- The approved protectors for competitors are governed by the list of approved protectors for competitions organized by the Czech Taekwon-Do ITF
- open hand protectors are NOT accepted outside of students

Weight categories

- Younger youth male/female -25, -30, -35, -40, +40 kg
- Older youth male -35, -40, -45, -50, -55, -60, +60 kg
- Older youth female -30, -35, -40, -45, -50, +55 kg
- Younger juniors male -45, -50, -55, -60, -65, +65 kg
- Younge juniors female -40, -45, -50, -55, -60, -65, +65kg
- Older juniors male -45, -51, -57, -63, -69, -75, +75 kg
- Older juniors female -40, -46, -52, -58, -64, -70, +70 kg

V. COMPETITION SYSTEM

The system of competition will be one-on-one (league). In case there are 6 or more competitors in a given category, they will be divided into several groups.

In groups, competitors will compete only in compulsory line-up and in soft kick / point fighting / sparring 1 x 2 minutes (or 1,5 min).

In the finals, 1 optional + 1 compulsory routine and in soft kicking / point fighting / sports fighting 2×2 minutes (respectively 1,5min).

The group match can end in a draw and each competitor gets 1 point in the table.

2 points are scored for a win. One third place will be awarded and contested.

VI. RULES

The competition will be held according to the rules of the EITF, Competition Directive No. 10 of the Czech Taekwon-Do ITF and these regulations.

Competitors with 10th kup (white belt) can compete without a dobok.

VII. PROTEST

A protest against the judges' verdict during the competition can only be made by the coach, in writing in accordance with the procedure (to be notified immediately after the match to the chairman of the jury and delivered back to the respective ring no later than 5 minutes after receipt of the form), with a deposit of 1.000,- CZK in the hands of the chairman of the jury.

The protest will then be discussed and resolved by the Committee of Judges (CoJ). The decision of the CoJ is final.

VIII. JUDGES

The registration of referees for the competition is done online through the members' portal of the association with the knowledge of the head of the subject. The total maximum number of judges for this event is 28.

Meals - Lunch will be provided for the judges.

Referee Responsibilities. Referees are required to be dressed according to ITF rules (incorrect dress code may be penalised with a deduction of 200,-CZK/day/item) and be present on the competition area of the hall for the duration of the competition day as instructed by the Head Referee and be fit to officiate. Failure to comply with the above may result in a reduction or non-payment of the judging fee.

Judges' fees will be paid at the end of the day.

IX. NUMBER OF COMPETITORS

There is no limit to the number of competitors that each entity may nominate for the competition.

X. TROPHY

Medals will be awarded for 1st, 2nd and 3rd place in each category. There will be only 1 x 3rd place in all categories.

Trophies will also be presented to the top individual (ninja boy, ninja girl, junior boy, junior girl, senior boy, senior girl, junior boy, junior girl, senior girl, senior girl) as well as the top three schools.

XI. OTHER

Change in the start list

Any change in the start list (e.g. due to incorrect classification of a competitor in a category, etc.) after the coaches' consultation will be made for a fee of 1.000,- CZK.

Doping

The Team Leader (coach) is the guarantor that the competitors of his/her team are familiar with the content of Directive No. 14 (Guidelines for the fight against doping within the system of all competitions of the Federation).

XII. COVID MEASURES

The Organiser reserves the right to modify the scope of the measures required depending on the Government Regulations currently in force at the time of the competition.

The competition is organized with the material support of the Czech Taekwon-do ITF.
